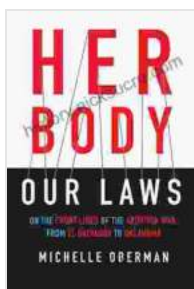

History of Her Body Our Laws

In addition to these legislative campaigns, HBOL is also working to build support for reproductive justice through grassroots organizing, education, and advocacy.

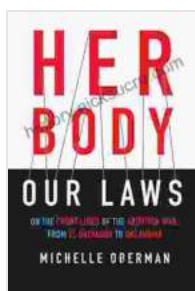
Get Involved

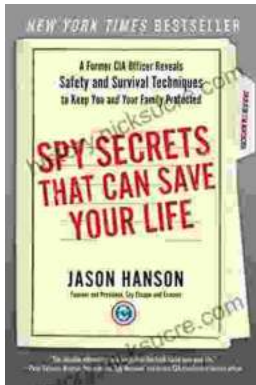
